LIABILITY – ASSUMPTION OF RISK AND RELEASE OF

It is expressly agreed that all use of Global Sports Twin Creeks Sunnyvale, Inc. facilities shall be undertaken by members at their sole risk, and the park shall not be subject to any claim, demand, or for any loss, damage, injury, or death caused to any member, member's family or guest, from any cause does hereby expressly forever release and discharge the park, its agent, employees, successors and assigns, for all such claims, demands, injuries, damages, rights or causes of accident.

It is further agreed that as a participant in Global Sports Twin Creeks Sunnyvale, Inc. leagues, tournaments, and special events, we the undersigned knowingly and voluntarily assume any and all risks inherent to our participating and agree to abide to all regulations established by Global Sports Twin Creeks Sunnyvale, Inc.

I further waive any right to claim against Global Sports Twin Creeks Sunnyvale, Inc., their officials, volunteers, agents or employees for loss of life, bodily injury, property damage and/or loss, or personal loss that may be sustained as a result of my participating in Global Sports Twin Creeks Sunnyvale, Inc. leagues, tournaments, and special events.

The Park shall not be responsible for articles lost, stolen or damaged in the park or on the premises.

PLAYERS' CODE OF CONDUCT

1. The Team Manager will be responsible for the conduct of all the players, and the players shall be responsible for the conduct of all the team's spectators. Any player that is ejected from the game for unsportsmanlike conduct must leave Global Sports Twin Creeks property.
2. Any player, coach, manager, or team representative that charges an umpire over a call will be ejected from the game for unsportsmanlike conduct and assessed the proper penalties.
3. No player may verbally harass and opposing player or spectator or say things that could promote ill feeling between the two teams or their spectators. No player may continuously argue with an umpire or make comments regarding an umpire's call or lack of a call. This includes making comments about how an umpire calls the game. It also includes comments regarding the pitching and ball and strike calls. In each game, the team or player may be given one warning, and if such conduct shall continue, a player or players can be ejected from the game for unsportsmanlike conduct, and escorted off the Global Sports Twin Creeks property.
4. Any player who uses foul language at an umpire or league representative can be ejected from the game and escorted off Global Sports Twin Creeks property for unsportsmanlike conduct without being given a warning.
5. Any player who is involved in unsportsmanlike aggressive behavior towards another player or spectator shall be ejected from the game and escorted off Global Sports Twin Creeks property. Any act by a person which is determined as being detrimental to Twin Creeks will result in that person being suspended from Global Sports Twin Creeks.
6. No player may consume any alcoholic beverage, narcotics, drugs, or other illegal substances during a game. No player shall play a game under the influence of alcohol, drugs, or other illegal substances, nor can a player smoke on the playing field. Players failing to adhere to this rule can be suspended and/or assessed a fine.
7. Any player who is assessed a fine must pay this fine before that player will be allowed to play in his/her next game. This includes a penalty levied against a player playing on another team at Global Sports Twin Creeks. Playing in a game before a fine has been paid or playing while suspended will result in a forfeiture of that game, further suspension, and possible increase of assessed fine. Any suspension and/or assessed fine may be appealed to the League Office.

MANAGER'S STATEMENT

I acknowledge that, in consideration for our being allowed to use the Global Sports Twin Creeks facility, it is my responsibility to ensure that all players have read and understand the above code of conduct and have signed the liability/injury waiver. I also understand any player who has not signed can be considered an illegal player which may result in forfeiture. If any player playing for my team has not signed this form or the player addition for, I hereby represent, under penalty of perjury, that I am authorized, by my signature on this form, to make such injury waiver for him or her, and I further agree to defend and indemnify Global Sports Twin Creeks from any claim or suit that any unsigned player may bring.
